- Supply, Deliver and Commission Mobile workshops five (5) Vehicles
- Supply, Deliver and Commission Leak Detection equipment as mentioned in Schedule (B), item 2
- Supply, Deliver and Commission Maintenance equipment items as mentioned in Schedule (B), item 3
- Supply, Deliver and Commission Noise loggers with its software or any needed accessories for operation
- Training for WAJ staff on operation of the Mobile leak detection workshops (duration 3 weeks), for a minimum of eight (8) operators, two (2) engineers and two (2) supervisors as specified in the Technical Specs.
- Implementation of the Noise loggers' system including on the job training for 3 WAJ staff for 3 months duration.
- 2. The following selection criteria will be applied to the bidders. The bidder may be a firm, or joint venture consisting of a leading partner and or more other partners providing complementary supplies/ services as per their specific role and/or specialisation.

a) Professional Capacity:

The Bidder must have an experience of at least 5 years in the same field of
supply, delivery and commission of mobile workshop equipped with leak
detection and maintenance equipment.

□ The Bidder and all Manufacturers of the offered Goods have to be certified acc. to ISO-9001: 2015, ISO-14001 or QA/QC procedure for the manufacturer. BS OH SAS 18001:2007 or ISO 45001 optional will be considered during technical evaluation.

b) Technical Capacity:

- □ The Bidder shall, during the last 5 years, have successfully completed at least 2 supply projects for mentioned Vehicles, each of these projects amounting to a minimum of 250,000 US dollar for each contract.
- □ The Bidder shall, during the last 5 years, have successfully completed at least 2 supply and commission projects for leak detection equipment as mentioned in schedule (B), item 2 and noise loggers as mentioned, each of these projects amounting to a minimum of 50,000 US dollar for each contract.
- □ The Bidder shall, during the last 5 years, have successfully completed at least 2 supply projects for Maintenance equipment items mentioned in schedule (B), item 3 each of these projects amounting to a minimum of 50,000 US dollar for each contract.
- For international Bidders, a local partner or supplier in Jordan who can provide additional storage capacity with 5 years' experience in the field of supply of the mentioned materials is preferable.
