The Employer, the Ministry of Water and Irrigation/Water Authority of Jordan (WAJ) has received financing from the **Arab Fund for Economic and Social Development** (AFESD) towards the cost of the Construction of Wastewater Systems in the Municipalities of Al-Junaid & North Jarash.

Background

The Works under this Prequalification process involve the construction of wastewater collection systems, pumping stations, and associated force mains in multiple locations, aimed at expanding and improving wastewater services in the project area. The Works under this Prequalification process are divided into three packages (C2, C3, and C4), as described below:

Package 2 (C2): Balelah Wastewater Collection System & Kareem Pumping Station:

- Construction of Wastewater collection System including house connections, approximately 52 Km of pipelines.
- Construction of Kareem Pumping Station, including civil, mechanical, electrical, and SCADA works, with associated force main with total length of approximately 2.2 Km
- The expected project duration is 16 months

Package 3 (C3):

The expected project duration is 24 months.

Lot (1): Junaid Main Pumping Station and Force Main

 Construction of the Junaid Main Pumping Station, including civil, mechanical, electrical, and SCADA works, and associated force main of approx. 20 km.

Lot (2): Sakhrah & Kufur Khal Wastewater Collection System:

• Construction of the Sakhrah and Kufur Khal wastewater collection systems including house connections (approx. 110 km of pipelines).

Package 4 (C4):

The expected project duration is 30 months.

(Lot 1) Ebben and Eableen Wastewater System:

 Construction of the Ebben and Eableen wastewater collection systems including house connections (approx. 90 km of pipelines), Ebben Pumping Station, including civil, mechanical, electrical, and SCADA works, and associated force main, and microtunneling works.

Lot (2): Samta & Ras Muneef Wastewater System:

 Construction of the Samta and Ras Muneef wastewater collection systems including house connections (approx. 24 km of pipelines), two pumping stations, and associated force mains.

Eligible Applicants

Sole Applicants:

Local Jordanian Contractors shall be classified as First Grade in Water and Wastewater works, as per GTD Classification.

International Contractors shall at least demonstrate equivalent qualifications by experience for the scope described above.

Or consortium (Joint Venture) of an international and/or Local Contractor with experience in equivalent wastewater projects. Local Jordanian Contractors JV shall be classified as First Grade in Water and Wastewater works as per GTD Classification. International Contractors shall demonstrate at least equivalent qualifications by experience for the scope described above.

Qualified Contractors are invited to apply on all packages. However, one contractor can be awarded more than one package. The Employer is not committed to floating all tenders at the same time, he can cancel any package at his discretion.

Section I. Instructions to Applicants

A. General

- 1. Scope of Application
- 1.1 In connection with the Invitation for Prequalification indicated in Section II, Prequalification Data Sheet (PDS), the Employer1, as defined in the PDS, issues this Prequalification Document ("Prequalification Document") to prospective applicants ("Applicants") interested in submitting applications, ("Applications") for prequalification to bid for the Works described in Section V, Scope of Works. In case the Works are to be bid as individual contracts, these are listed in the PDS.
- 2. Source of Funds
- 2.1 The Employer as indicated in the PDS has applied for or received financing (hereinafter called "funds") from Arab Fund for Economic and Social Development (hereinafter called "The Bank") towards the cost of the project named in the PDS. The Employer intends to apply the funds to eligible payments under the contract(s) resulting from the bidding for which this prequalification is conducted.
- 3. Eligible Applicants
- 3.1 An Applicant may be a firm that is a private entity, or a combination of such entities in the form of a joint venture ("JV") under an existing JV Agreement or with the intent to enter into such an agreement supported by Declarations of Association. In the case of a JV, all members shall be jointly and severally liable for the execution of the Contract in accordance with the Contract terms. The Applicant shall nominate an authorized representative who shall have the authority to conduct all business for and on behalf of the Applicant and any and all its members, if the Applicant is a JV, during the prequalification process, bidding (in the event the Applicant submits a bid) and during contract execution (in the event the Applicant is awarded the Contract). Unless specified in the PDS, maximum number of members in a JV is two.
- 3.1 A firm may apply for prequalification both individually, and as part of a JV, or as a subcontractor. If prequalified, it will not be permitted to bid for the same contract both as an individual firm and as a part of the joint venture. However, a firm may participate as a subcontractor in more than one bid, but only in that capacity. Bids submitted in violation of this procedure will be rejected.
- 3.2 Applicants shall not have a conflict of interest. Any Applicant found to have a conflict of interest shall be disqualified. An Applicant may be considered to have a conflict of interest for the purpose of this prequalification process, if the Applicant:
 - a. Directly or indirectly controls, is controlled by or is under common control with another Applicant; or
 - b. Receives or has received any direct or indirect subsidy from another Applicant; or
 - c. Has the same legal representative as another Applicant;
 - d. Has a relationship with another Applicant, directly or through common third parties, that puts it in a position

- to influence the application of another Applicant, or influence the decisions of the Employer regarding this prequalification process; or
- e. Any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the works that are the subject of the prequalification; or
- f. Directly or indirectly controls, is controlled by or is under common control with another Applicant; or
- g. Receives or has received any direct or indirect subsidy from another Applicant; or
- Has the same legal representative as another Applicant; or
- Has a relationship with another Applicant, directly or through common third parties, that puts it in a position to influence the application of another Applicant, or influence the decisions of the Employer regarding this prequalification process; or
- j. Any of its affiliates participated as a consultant in the preparation of the design or technical specifications of the works that are the subject of the prequalification; or
- Any of its affiliates has been hired (or is proposed to be hired) by the Employer as Engineer for the Contract implementation; or
- Has a close business or family relationship with a professional staff of the Employer (or of the project implementing agency, or of a recipient of a part of the loan) who: (i) are directly or indirectly involved in the preparation of the prequalification documents or specifications of the contract, and/or prequalification evaluation process; or (ii) would be involved in the implementation or supervision of such contract unless the conflict stemming from such relationship has been resolved in a manner acceptable to the Bank throughout the procurement process and execution of the contract.
- 3.3 An Applicant shall not be under suspension from bidding by the Employer as the result of the execution of a Bid–Securing Declaration.
- 3.4 An Applicant shall provide such evidence of eligibility satisfactory to the Employer, as the Employer shall reasonably request.

B. Contents of the Prequalification Documents

Documents

4. Sections of Prequalification 4.1 These Prequalification Documents consist of all sections indicated below, and which should be read in conjunction with any Addendum issued in accordance with ITA 6.

Pregualification Procedures

- a. Section I. Instructions to Applicants (ITA);
- b. Section II. Pregualification Data Sheet (PDS);
- c. Section III. Qualification and Evaluation;
- d. Section IV. Application Forms;
- 4.2 Unless obtained directly from the Employer, the Employer accepts no responsibility for the completeness of the Prequalification Documents, responses to requests for clarification, or Addenda in accordance with ITA 6. In case of any discrepancies, documents issued directly by the Employer shall prevail.
- 4.3 The Applicant is expected to examine all instructions, forms, and terms in the Prequalification Documents and to furnish with its application all information or documentation as is required by the Pregualification Documents.
- 5. Clarification **Prequalification Documents**
 - of 5.1 A prospective Applicant requiring any clarification of the Prequalification Documents shall contact the Employer in writing at the Employer's address indicated in the PDS. The Employer will respond in writing to any request for clarification provided that such a request is received no later than fourteen (14) days prior to the deadline for submission of the applications. The Employer shall forward a copy of its response to all prospective Applicants who have obtained the Prequalification Documents directly from the Employer, including a description of the inquiry but without identifying its source. If so, indicated in the PDS, the Employer shall also promptly publish its response at the web page identified in the PDS. Should the Employer deem it necessary to amend the Prequalification Documents as a result of a clarification, it shall do so following the procedure under ITA 6.
- 6. Amendment of **Pregualification Documents**
- 6.1 At any time prior to the deadline for submission of Applications, the Employer may amend the Prequalification Documents by issuing an Addendum.
- 6.2 Any Addendum issued shall be part of the Prequalification Documents and shall be communicated in writing to all prospective Applicants who have obtained the Prequalification Documents from the Employer. The Employer shall promptly publish the Addendum at the Employer's web page identified in the PDS.
- 6.3 To give prospective Applicants reasonable time to take an Addendum into account in preparing their Applications, the Employer may, at its discretion, extend the deadline for the submission of Applications.

C. Preparation of Applications

- 7. Cost of Applications
- 7.1 The Applicant shall bear all costs associated with the preparation and submission of its Application. The Employer will in no case be responsible or liable for those costs, regardless of the conduct or outcome of the prequalification process.
- 8. Language of Application
- 8.1 The Application as well as all correspondence and documents relating to the prequalification exchanged by the Applicant and the Employer, shall be written in the language specified in the PDS. Supporting documents and printed literature that are part of the Application may be in another language, provided they are accompanied by an accurate translation of the relevant passages in the language specified in the PDS, in which case, for purposes of interpretation of the Application, the translation shall govern.
- **Application**
- **9. Documents Comprising the** 9.1 The Application shall comprise the following:
 - a. The Application Submission Sheet, indicating the Applicant's name, address, telephone, fax and email. If the Applicant is an association, the Application Submission Sheet shall also describe the form of association and list the association members;
 - b. A notarized Power of Attorney authorizing the representative of the Applicant, designated in accordance with ITA 3.1 to submit the Application on behalf of the Applicant. If the Applicant is a JV, the Power of Attorney shall be provided by the Lead Member nominated in the JV Agreement or in the Declarations of Association, submitted in accordance with ITA 3.1. If the representative of the Applicant is the owner, member or director of the Applicant or the Applicant's Lead Member, if so, nominated in accordance with ITA 3.1, a Power of Attorney shall not be necessary.
 - Statements and Declarations: False information provided in the following Statements and Declarations by the Applicant or in the case of an JV by any of the JV members shall lead to the exclusion of the Applicant from the tender process:
 - If the Applicant is an existing JV, the Applicant shall submit a proof of the existing Association Agreement, indicating the Lead Member. If the Applicant is a JV, which the members intend to form for the purpose of executing the contract, each member of the association shall submit a
 - Declaration of Association, indicating the Lead Member, in the format provided in Annex Section IV, Application Forms.
 - iii Declaration of Undertaking in the format provided in Section IV, Application Forms. If the Applicant is a JV, only one Declaration of Undertaking must be submitted, i.e., the representative of the JV can sign on behalf of the JV subject to a power of attorney.
 - d. All Application forms and required attachments, provided in Section IV, Application Forms. If the Applicant is a single

- entity, in accordance with ITA 3.1, it should not include form ELI 1.2 in its application.
- e. Any other documents required in the PDS.
- 10. Application Submission Form
- 10.1 The Applicant shall complete an Application Submission Form as provided in Section IV, Application Forms. This Form must be completed without any alteration to its format.
- **Eligibility of the Applicant**
- 11. Documents Establishing the 11.1 To establish its eligibility in accordance with ITA 3, the Applicant shall complete and sign the Declaration of Undertaking as provided in Section IV, Application Forms without any alteration to its format and furnish supporting documentation as specified in Forms ELI 1.1, ELI 1.2(a) and ELI 1.2(b).
- 12. Documents Establishing the Qualifications of the **Applicant**
- 12.1 To establish its qualifications to perform the contract(s) in accordance with Section III, Qualification and Evaluation, the Applicant shall provide the information requested in the corresponding Forms included in Section IV, Application Forms.
- 13. Signing of the Application and Number of Copies
- 13.1 The Applicant shall prepare one original of the documents comprising the Application as described in ITA 9 and clearly mark it "ORIGINAL". The original of the Application shall be typed or written in indelible ink and shall be signed by a person duly authorized to sign on behalf of the Applicant. In case the Applicant is a JV, the Application shall be signed by an authorized representative of the JV, designated in accordance with ITA 3.1, on behalf of the JV.
- 13.2 The Applicant shall submit copies of the signed original Application, in the number specified in the PDS, and clearly mark them "COPY". In the event of any discrepancy between the original and the copies, the original shall prevail.

D. Submission of Applications

- **Applications**
- **14.1** Sealing and Identification of 14.1 The Applicant shall enclose the original and the copies of the Application in a sealed envelope that shall:
 - a. bear the name and address of the Applicant;
 - b. be addressed to the Employer, in accordance with ITA 15.1; and
 - c. bear the specific identification of this prequalification process indicated in the PDS 1.1.
 - 14.2 The Employer will accept no responsibility for not processing any envelope that was not identified as required in ITA 14.1 above.
- 15. Deadline for Submission of **Applications**
- 15.1 Applicants may either submit their applications by mail or by hand. Applications shall be submitted in accordance with the instructions, including the address and deadline, stipulated in the PDS.
- 15.2 The Employer may, at its discretion, extend the deadline for the submission of Applications by amending the Prequalification Documents in accordance with ITA 6, in which case all rights and obligations of the Employer and the Applicants subject to the previous deadline shall thereafter be subject to the deadline as extended.
- 16. Late Applications
- 16.1 Late Applications received after the deadline indicated in ITA 15.1 will be rejected.
- 17. Opening of Applications
- 17.1 The Employer shall open all Applications at the date, time and place specified in the PDS. Late Applications shall be treated in accordance with ITA 16.1.
- 17.2 The Employer shall prepare a record of the opening of Applications, which shall include, as a minimum, the name of the Applicant and whether the Application has been received in time.

E. Procedures for Evaluation of Applications

- 18. Confidentiality
- 18.1 Information relating to the Applications, their evaluation and result shall not be disclosed to Applicants, or any other persons not officially concerned with the prequalification process until the notification of prequalification results is made to all Applicants in accordance with ITA 26.
- 18.2 From the deadline for submission of Applications to the time of notification of the results of the prequalification in accordance with ITA 26, any Applicant that wishes to contact the Employer on any matter related to the prequalification process (except as specified in 18.1 above), may do so only in writing.
- 19. Clarification of Applications
- 19.1 To assist in the evaluation of Applications, the Employer may, at its discretion, ask an Applicant for a clarification of its application, to be submitted within a stated reasonable period of time. Any request for clarification from the Employer and all clarifications from the Applicant shall be in writing.
- 19.2 If an Applicant does not provide clarifications and/or documents requested by the date and time set in the Employer's request for clarification, its Application shall be evaluated based on the information and documents available at the time of evaluation of the Application.

20. Responsiveness **Applications**

of 20.1 The Employer shall reject an Application that is not substantially responsive to the requirements of this prequalification document. An Application shall be considered as responsive if the following documents are submitted:

Responsiveness criteria

- 1. Declaration of Undertaking (ITA 9.1 d) (III))
- 2. Application Submission Form (ITA 9.1 a)
- 3. Notarized Power(s) of Attorney authorizing the representative of the Applicant (ITA 9.1 b)
- 4. If the Applicant is an association, either proof of the existing Association Agreement or a Declaration of Association (ITA 9.1 d) (II))
- 21. Domestic Bidder **Preference**
 - **Price** 21.1 A margin of preference for domestic bidders shall not apply in the bidding process resulting from this prequalification unless otherwise specified in the PDS.
- 22. Subcontractors
- 22.1 Unless otherwise stated in the PDS, the Employer does not intend to execute any specific elements of the Works by subcontractors selected in advance by the Employer (nominated subcontractors).
- 22.2 A "specialized sub-contractor" is a sub-contractor hired for specialized work as defined by the Employer. If no specialized work is specified by the Employer as such, sub-contractors experience shall not be considered for Applications evaluation.

F. Evaluation of Applications and Prequalification of Applicants

23. Evaluation of Applications

- 23.1 The Employer shall evaluate the responsive Applications using the factors, methods, criteria, and requirements defined in Section III, Qualification and Evaluation, to evaluate the qualifications of the Applicants, and no other methods, criteria, or requirements shall be used.
- 23.2 Only the qualifications of the Applicant shall be considered. In particular, the qualifications of a parent or other affiliated company that is not party to the Applicant under a JV in accordance with ITA 3.1 shall not be considered.
- 23.3 In case of multiple contracts, Applicants should indicate in their applications the individual contracts in which they are interested. The Employer shall prequalify each Applicant for the maximum combination of contracts for which the Applicant has thereby indicated its interest and for which the Applicant meets the appropriate aggregate requirements. The Qualification and Evaluation are mentioned in Section III.
- **All Applications**
- 24. Employer's Right to Reject 24.1 The Employer reserves the right to annul the prequalification process and reject all Applications at any time, without thereby incurring any liability to the Applicants.
- 25. Prequalification **Applicants**
- of 25.1 The Employer shall assess the responsive Applications in terms of the Eligibility and Qualification Criteria and methods set out in Section III, Qualification and Evaluation.
 - 25.2 The Employer shall determine the fulfilment of minimum requirements on a pass/fail basis as per Section III, Qualification and Evaluation.
 - 25.3 An Applicant shall be considered pregualified if:

- its application is considered responsive in accordance with ITA 20.1 and;
- b. its application has met all the pass/fail requirements in accordance with ITA 25.2.

- 26. Notification Prequalification
- of 26.1 The Employer shall notify all Applicants in writing of the names of those Applicants who have been prequalified. In addition, those Applicants who have been disqualified will be informed separately.
 - 26.2 Applicants that have not been prequalified may write to the Employer to request, in writing, the grounds on which they were disqualified.
- 27. Invitation for Bids
- 27.1 Promptly after the notification of the results of the prequalification, the Employer shall invite bids from all the Applicants that have been prequalified.
- 28. Changes in Qualifications of Applicants
- 28.1 Any change in the structure or formation of an Applicant after being prequalified in accordance with ITA 25 and invited to bid (including, in the case of a JV, any change in the structure or formation of any member thereto) shall be subject to the written approval of the Employer prior to the deadline for submission of bids. Such approval shall be denied if (i) as a consequence of the change, the Applicant no longer meets the qualification criteria set forth in

Section III, Qualification and Evaluation; or (ii) in the opinion of the Employer, the change may result in a substantial reduction in competition. Any such change should be submitted to the Employer not later than fourteen (14) days after the date of the Invitation for Bids.




Figure 1: Central Bank of Jordan for Exchange rates

Section V. Scope of Works

1. Project Overview




Figure 1: Project Area

The project area is located in the northern region of Jordan, within three governorates: Irbid, Ajloun, and Jarash (see Figure 1). The project covers the following municipalities and districts:

- AL Junaid municipality, which includes three urban districts Ebben, Eableen, and Sakhrah.
- Ras Muneef and Samta are located within Ajloun Municipality.
- Kufur Khal and Balelah fall under Al-Naseem Municipality situated in the northern part of Jarash.

The current and projected population of the project area is illustrated below.

2. Project Area and Environmental Conditions

The project area is predominantly residential in land use. The main catchment area drains towards the An-Nuayyima intersection, located west of the Wadi Hassan Wastewater Treatment Plant (WWTP), and includes several wadis.

The project area experiences a Mediterranean climate, with cool winters and warm summers. Mean temperatures range from about 10°C in winter to 27°C in summer. Rainfall is concentrated in the winter months, reaching up to 350 mm annually, while summers are generally dry. Humidity, solar radiation, and evaporation show strong seasonal variation, with the highest evaporation and radiation occurring between May and October.

3. Description of the contact works

The Project comprises the construction of wastewater collection and transmission systems across several areas, divided into three main contract packages (Packages 2, 3, and 4), each with separate lots. The scope includes construction of gravity sewer networks, pumping stations, force mains, and specialized trenchless works. The detailed scope per package is as follows:

Package 2 (C2):

Balelah Wastewater Collection System & Kareem Pumping Station – Construction of wastewater collection networks including house connections (approx. 52 km) with diameters range (150 mm – 400 mm), one pumping station, and associated force main.

Package 3 (C3):

- **Lot 1: Junaid Main Pumping Station and Force Main** Construction of a major pumping station and a steel force main DN 500 mm of approximately 20 km, including civil, mechanical, electrical, and SCADA works.
- **Lot 2: Sakhrah & Kufur Khal Wastewater Collection System** Construction of wastewater collection networks of approx. 110 km including house connections with diameters range (150 mm 400 mm).

Package 4 (C4):

- **Lot 1: Ebben & Eableen Wastewater System** Construction of wastewater collection networks including house connections (approx. 90 km diameters range (150 mm 400mm), one pumping station, associated force mains, and trenchless microtunneling works.
- **Lot 2: Samta & Ras Muneef Wastewater System** Construction of wastewater collection networks including house connections (approx. 24 km- diameters range (150 mm 200mm), two pumping stations, and associated force mains.

Specialized works include trenchless construction using microtunneling technology. Contractors are required to demonstrate relevant experience in trenchless methods as part of their prequalification submission.
